

**TNT TENT & TABLE RENTALS**  
**RENTAL CONTRACT**

This is a contract. This contract contains important terms and conditions including TNT's disclaimer from all liability for injury or damage and details of customers obligations.

These terms and conditions are part of this contract. **PLEASE READ THEM CAREFULLY.** Any town permits that are required are the responsibility of the customer.

**PHYSICAL CONDITION OF RENTAL ITEMS.**

You acknowledge that prior to taking the rental items, that they are in good condition, and that you will return them in the same condition, ordinary use expected. If any of these items are lost, stolen, or damaged under any circumstances while rented, you agree, regardless of fault, that you will be responsible for all charges and costs for replacement, repair and loss of use. You also agree to return these items in a clean condition and if you do not, then you will pay a cleaning charge.

Make sure to keep all tables and chairs dry and out of the rain. Be sure to turn off sprinklers while tents, tables and chairs are on your lawn. Please be sure to stack all chairs as they were when delivered.

**CUSTOMERS RESPONSIBILITY FOR RENTAL ITEMS.**

Customer assumes full responsibility for all rented items, including proper use of them.

**PLEASE DO NOT PUT TAPE, PAPER MACHE OR SILLY STRING ON ANY OF OUR TENTS, TENT POLES, TABLES OR CHAIRS.**

Doing so will definitely require you to pay a cleaning and or damage fee.

The customer understands that a tent is used to protect from the sun and rain. In severe weather, it should not be used for protection, as injury could occur if the tent were to collapse. To avoid injury in severe weather, seek indoor shelter from the storm.

TNT Rentals will not be liable for any damages or injury at your event. Once delivery is complete and customer is satisfied with items delivered, contract is signed. Customer then assumes responsibility and releases TNT Rentals from all liability resulting in injury, regardless if it is weather related or some other cause. In the case of high winds exceeding 25mph, TNT reserves the right to use our discretion in putting up a tent.

Rental items belong to TNT Tent & Table Rentals. When setting up for your event, we will let you know on what day we will be returning to take everything down. You must allow us to pick up on the scheduled day. If there is a change for any reason, TNT will notify you. You agree that TNT has the right to enter your property to repossess our rented items, without recourse by you. Failure to return rented items may subject you to criminal prosecution. You agree to pay daily rental charges after the due date until items are returned, unless previous arrangements have been made with us.

**WAIVER OF DAMAGE**

Customer agrees to release TNT Rentals of Liability for any damage to any property when we are delivering, installing, and picking up equipment from your property. This includes high wind storm related damage (including, during your event), ruts in the grass, scratches or cracks on installed surfaces. Any underground sprinkler heads, lines and or wires must be clearly marked.

A \$75 deposit is required to reserve your date and package. The customer has the right to cancel with no penalty up to 7 days prior to the event. Cancellation within 7 days of the event you will lose the \$75 deposit.
